Based on the actual customer usage data, most of the customers who purchased modules mentioned in Para 1 did not use Espressif common AT firmware. Among the few who did, there were varying requirements for firmware versions. Therefore, Espressif will not flash the Espressif common AT firmware on the modules in Para 1 before shipment.



